Alternative systems with electrical float switches, pumps, or mechanical components should be inspected more often, generally once a year.

Under the GBRs, anyone with a septic tank discharging into a watercourse must replace it or upgrade it by 1 January 2020, or sooner if the property is sold before this date, or if the Environment Agency (EA) finds that it is causing pollution. The soakaway should be designed in accordance with the guidance provided in BS8301 and in BRE Soakaway Design (1991). It should not be located within 5m of any dwelling and as far away as possible from the percolation area (at least a minimum of 5m separation distances should be used).

The septic tank is a buried, water-tight container usually made of concrete, fiberglass, or polyethylene. Its job is to hold the wastewater long enough to allow solids to settle down to the bottom forming sludge, while the oil and grease floats to the top as scum.
